Na osnovu člana 223. Zakona o radu ("Sl. glasnik RS" br. 24/05 i 61/05), generalni direktor Privrednog društva Telenor d.o.o, donosi sledeće

Based on Article 223 Labour Act ("Official Gazette of RS" Nos. 24/05 and 61/05), Director General of the Company Telenor d.o.o, adopts the following

REŠENJE

o utvrđivanju reprezentativnosti sindikalne organizacije "Sindikata - Telenor"

I Utvrđuje se reprezentativnost sindikalne organizacije "Sindikata Telenor", koji je upisan u registar sindikata rešenjem Ministarstva rada, zapošljavanja i socijalne politike broj 110-00-323/206-02 od 27.03.2006. godine, pod rednim brojem 19722.

II Lice ovlašćeno za zastupanje i predstavljanje sindikata je Dejan Roganović, JMBG 1612962710149, po zanimanju diplomirani inženjer elektrotehnike, na poslovima Senior Power Supply Engineering Supervision Engineer.

Obrazloženje

Dana 05.03.2007. godine, "Sindikata - Telenor" je podneo zahtev za utvrđivanje reprezentativnosti, saglasno članu 226. Zakona o radu, "Sl. glasnik RS", broj 24/05 i 61/05, (u daljem tekstu: Zakon), sa svim potrebnim dokazima o ispunjenosti uslova reprezentativnosti.

Sindikata je osnovan i deluje na načelima slobode sindikalnog organizovanja i delovanja, nezavisan je od državnih organa i poslodavaca i finansira se iz članarine i drugih izvora (član 218. Zakona).

DECISION

on representativeness verification of the labour union "Union - Telenor"

I Hereby is a verification of representativeness of the labour union "Union - Telenor", registered in union register by decision of Ministry of Labour, Employment and Social Welfare, no 110-00-323/206-02 as of March 27, 2006, no. 19722.

II Person authorized for representation of the Union is Dejan Roganović, Personal ID no 1612962710149, Bachelor of Science electronics engineer, for a position as Senior Power Supply Engineering Supervision Engineer.

Rationale

On the 5th of March, 2007, the "Union - Telenor" has submitted the request for representativeness verification, according to the article 226 of the Labour Act, "Official Gazette of RS" No. 24/05 and 61/05, (hereinafter: the Law), with all necessary evidences that representativeness conditions are met.

The Union is established and acting based on principles of free union organising and acting, independently on governmental authorities and employers, and is supported by own means - from membership fee and other resources (article 218 of the Law).

Sindikata ima 167 članova, što čini 15,1268% zaposlenih od ukupnog broja zaposlenih, te predstavlja reprezentativni sindikat u smislu člana 219. Zakona.

The Union has 167 members, that is 15,1268% of total number of employees, therefore it is representative union in accordance with the article 219 of the Law.
